

# **Certification Part II** WHSC Sector Programs



Following completion of *Certification Part I* training, joint health and safety committee (JHSC) Certification candidates are required to complete *Certification Part II* training.

This training must be approved by the Ministry of Labour's Chief Prevention Officer and delivered by an approved provider. Training must also address at least six hazards that are relevant to the JHSC's workplace. The hazards to be addressed by *Certification Part II* training should be discussed and selected by the JHSC.

WHSC and all our training options for *Certification Part II* have been approved. The WHSC offers more than 60 hazard-specific modules for a more customized approach. Each is designed to build on the knowledge gained in *Certification Part I* training and apply it to specific workplace hazards with emphasis on measures to eliminate or control exposures. As a second option to ease compliance, workplaces can enroll in one of several WHSC sector programs (see below for more details). These programs address hazards common to the majority of workplaces in a given sector.

Regardless, *Certification Part II* training must also be a minimum of two days in duration. In most cases, this training must be taken within six months of *Certification Part I* training.

**WHSC offers the following sector programs.** All exceed the minimum two days of required training as experience tells us a more comprehensive program is necessary in order to properly address the significant hazards in each sector. ### Adult Probation and Parole (8 hazard modules – 3 days)

- Day 1: EMFs and Dirty Electricity; Indoor Air; Vehicle Driving Hazards
- **Day 2:** Workplace Violence and Harassment; Stress in the Workplace; Emergency Preparedness and Pandemic Response Plans

#### Tourism & Hospitality (9 hazard modules – 3 days)

Day 1: Indoor Air; Office Biohazards: Viruses, Moulds and Bacteria; Heat and Cold Stress

- **Day 2:** Emergency Preparedness and Pandemic Response Plans; Workplace Violence and Harassment; Work Design
- Day 3: Lockout; Electrical Hazards; Manual Material Handling

#### Transportation (9 hazard modules – 3 days)

- Day 1: Vehicle Driving Hazards; Noise; Manual Material Handling
- **Day 2:** Vehicle Emissions; Transportation of Dangerous Goods; Emergency Preparedness and Pandemic Response Plans
- **Day 3:** Workplace Violence and Harassment; Critical Incident and Post Traumatic Stress; Walking and Working Surfaces

#### Youth Detention Centres (17 hazard modules – 6 days)

TRAINING

**Note:** To maintain certification status, a certified member of a joint health and safety committee (JHSC) in Ontario must complete a Refresher program approved by the Ministry of Labour's Chief Prevention Officer and within three years of completing *Certification Part II* and every three years thereafter. Like all Certification training, this Refresher program must be delivered by an approved provider. The WHSC *Certification Refresher* training is approved and the WHSC is an approved training provider.
