Your Training Duties

Workplace law recognizes the need for health and safety training. Ontario's *Occupational Health & Safety Act (the Act)* places **significant legal duties on employers** to train supervisors, joint health and safety committee (JHSC) members, health and safety representatives and workers.

In addition to general duties to provide information, instruction and supervision, health and safety law spells out many other legal training obligations for employers. These include training related to:

- **WHMIS**
- **Confined Space Entry**
- **Violence and Harassment**
- **JHSC Certification—Part I and II**
- **Mobile Equipment Operators.**

And these significant training obligations are about to expand. The Ontario government has introduced a new regulation calling for mandatory health and safety awareness training for all workers and front-line supervisors. Other promised training regulations include training for high hazard work, like working at heights, as well as training for health and safety representatives in smaller workplaces.

Many workplaces begin with all-important Certification Training. The *Act* requires establishment of a joint health and safety committee (JHSC) in most workplaces with 20 or more workers. Employers must also ensure one member representing workers and one representing management complete a **two-step Certification Training** process known as *Basic Certification Part I and Workplace Hazard-Specific Training or Certification Part II*.
